### Third Angle shows way on certification

Victorian-based fabricator Third Angle Engineering is showing the way for larger businesses when it comes to compliance - with the business achieving CC3 certification under the Steelwork Compliance Australia (SCA) scheme and working towards L3 under the Steel Sustainability Australia (SSA) scheme. The Dandenong South business employs more than 50 staff and specialises in large and small-scale one-off projects and prototypes in the building, mining, telecommunications, food and beverage, and bulk materials handling industries. Third Angle Engineering operates from a 5,500 sq metre factory complete with four overhead cranes and maintains a full staff of qualified boilermakers, sheet metal workers, fitter and turners, painters, draftsmen, and project managers to help customers translate their visions into reality.

### Strong interest in sustainability awards

The inaugural ASI Steel Sustainability Awards have attracted strong interest, with entries now closed. The awards recognise exemplary sustainable use of steel in buildings and construction projects; and company steel-related initiatives. Winners will be announced online and via the ASI social media platforms in February 2024. Entrants are vying for awards in four categories: large projects equal or greater than \$10million; small projects less than \$10million; company or project initiative (large businesses); and company or project initiative (small businesses). Winners will be profiled in ASI media releases, newsletters and social media; and able to badge their business with the Steel Sustainability Awards winners logo.



Large steel companies face new Federal Government climate-related financial and greenhouse gas emissions disclosure requirements from next year. The disclosures were among reforms discussed at last week's Australian Sustainable Built Environment (ASBEC) council meeting in Canberra attended by ASI sustainability manager Jerusha Beresford. The mandatory regime for large entities and large emitters starts 1 July 2024. Smaller organisations will be phased-in from 1 July 2026 and 1 July 2027. In July, Federal Minister for Climate Change Chris Bowen announced specific net-zero emissions plan for the built environment sector including steel and concrete. ASI is consulting with Department of Scientific and Industrial Research on the plan. Governments meanwhile are supporting net-zero targets by funding the development of a national framework for measuring, benchmarking and certifying emissions from construction and building materials ie, the NABERS embodied carbon tool, which is on track to launch in June 2024. Embodied carbon is also on the Australian Building Codes Board's agenda to implement into the National Construction Code.

A mix of commercial tools are now available to help businesses manage their sustainability risk. On November 22, a panel of industry experts including ASI compliance and strategic relations manager Phil Casey explored electricity price peaks and how businesses can reduce them in a seminar run by ASI corporate partner Choice Energy (www.choiceenergy.com.au). Meanwhile ASI member GridBeyond has launched Forecaster, a tool to manage and monetise energy assets and reduce costs (go to https://gridbeyond.com/lp/usa\_forecaster\_one-page-flyer/ for details).

# Push for more women in building

A new NSW Government initiative aims to have 15% of NSW construction industry jobs filled by women by 2030. The three-year Australian Sustainable Built Environment Council Women in Construction Future Leaders Pilot program aims to create easier and clearer pathways for women to apply, enter and progress in the industry. It follows an industry survey revealing participation rates above the national average of 12% but as low as 5% in some workplaces. Women in leadership and executive positions fell to only 10%. The survey interviewed more than 130 women designers, architects, landscape architects surveyors, engineers. professionals, project managers, trades, associations, and product suppliers in the building industry.
